# Choosing your gift

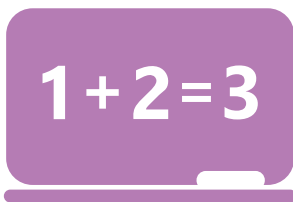
## Leaving a legacy that works for you

There are several ways in which you may decide to leave a gift in your Will. These include:



### Residuary Gift

A percentage of your estate after all other gifts and expenses are distributed



### Pecuniary Gift

A specified sum of money



### Specific Gift

A specified item such as shares, jewellery or property



### Conditional Gift

A gift that takes effect only in certain circumstances

**If you would like to leave a gift to Frimley Health Charity, here are some of the important things to remember:**



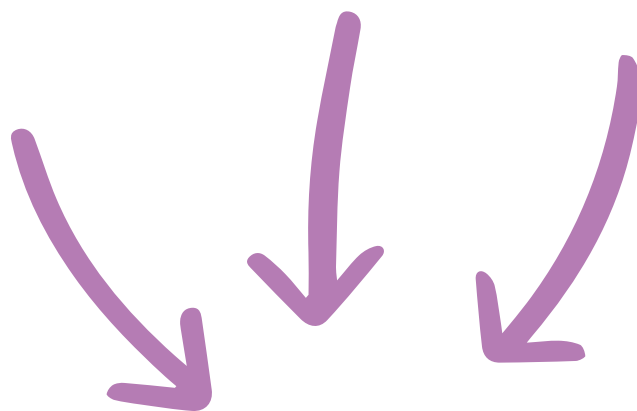
It's really important to include our full name. Please ensure you specify you are leaving your gift to "Frimley Health Charity, Registered Charity Number: 1049600 " If you leave it to 'Frimley Health' or 'Wexham Park Hospital' your entire gift may not be received.



It's really important to decide what kind of gift you would like to leave. Discuss the type of gift (residuary/pecuniary/specific/conditional with your solicitor and ensure this is specified in your Will.



Please do let us know about your gift, so we can understand your motivations and thank you properly. We can also then keep you informed on areas of our work which may interest you!

# Any questions?

**Can I change my Will later?**

Yes, you can update your will at any time. We recommend consulting your solicitor to ensure any changes are legally binding.

**Do I have to inform the charity?**

While it's not mandatory, letting us know about your gift allows us to thank you and plan for the future.

**What if I already have a Will?**

You can add a gift by making a codicil (an addition) to your existing will. Speak to your solicitor for advice.
